Structure, Governance and Management

The Society was founded in 1910 by Canon Charles Wilmer Foster, and subsequently endowed by Kathleen Major, with the object of printing records and documents relating to church, parochial, manorial and family history of the county and ancient diocese of Lincoln.

Policies to enable the Society to achieve its charitable objectives are determined by its Council of trustees, which meets once or twice each year. An annual report and any changes to the governing document are put before members at the Annual General Meeting, usually held in October or early November. The day to day running of the Society is delegated by Council to the Finance and Publications Committee and to its Officers.

Membership is open to all, on payment of the annual subscription, currently set at £25 for all members, in return for which, members are supplied with the annual main series publications of the Society. Subscriptions are due on 1 August each year, but members may join at any time during the year and receive a full year's benefit. Most of the Society's publications deal with Lincolnshire, but some of the volumes include matter relating to the counties of Bedford, Buckingham, part of Hertford, Huntingdon, Leicester, Northampton, Oxford and Rutland, which were in former days included in the diocese of Lincoln. Members are entitled to purchase back volumes and publications in the additional series at a discount.

The governing document is reproduced here.

The Rules of the Society are:

- 1. The Society shall be called the LINCOLN RECORD SOCIETY (hereinafter referred to as the Society).
- 2. The object of the Society shall be the advancement of public education in the history of the ancient diocese of Lincoln and the county of Lincolnshire especially by the transcription, editing and publication of original historical documents. The word 'Diocese' in this clause shall include any counties which have at any time formed part of the Diocese of Lincoln.
- 3. Membership of the Society shall be constituted by the payment of the annual subscription, or, in the case of life members, of the composition.
- 4. The annual subscription shall be determined from time to time by the trustees and shall be payable on the first day of August in every year. A composition of an amount twenty times that of the annual subscription shall constitute life membership from the date of composition.
- 5. The management of the affairs of the Society shall be vested in a Council consisting of the president, secretary, general editor, treasurer and a number of at least seven and not exceeding twenty other members of the Society to be elected at the annual general meeting. Vacancies occurring between annual general meetings may be filled by the Council. Three shall form a quorum.
- 6. Each member shall be entitled to one copy of every work published in the main series by the Society in respect of his year of membership. No person shall receive any such volume until his subscription for the year in respect of which the volume is published has been paid. Provided that any member may be supplied with any of the publications, including the additional series, on such terms as the Council may from time to time determine.

- 7. Persons who are not members of the Society may be supplied with the publications of the Society on such terms as the Council may determine.
- 8. The funds of the Society, including the vouchers or securities for any investments, shall be kept at a Bank to be selected by the Council in the name of the Society. Such investments shall only be dealt with by an authority signed by the Secretary and such other person or persons as the Council may from time to time appoint.
- 9. The accounts of the receipts and expenditure of the Society, and of its assets and liabilities, up to the 31st July in each year, shall be scrutinised in accordance with relevant legislation for the time being by an appropriate person or body to be appointed by the Society.
- 10. An annual general meeting of the members shall be held in the Autumn, to receive a report upon the work of the Society and the General Editor's report, to receive the Treasurer's financial statement and to elect an appropriate scrutineer in accordance with Rule 9, to elect officers and a council for the ensuing year, and to transact the general business of the Society.
- 11. The Council may require the accuracy of any transcript, calendar or translation to be tested on their behalf before it is printed.
- 12. The editor of a volume shall be entitled to receive five copies of the work.
- 13. The Secretary shall keep a minute book wherein shall be entered a record of the transactions as well at meetings of the Council as at general meetings of the Society.
- 14. The rules shall only be amended at a General Meeting called for that purpose giving at least 21 days notice of the proposed amendment. No amendment shall be made to the constitution that would cause the Society to cease to be a Charity at Law. Any alteration to the constitution must receive the assent of not less than two-thirds of those present and voting. Any amendment to Clause 2 or Clause 15 or this Clause shall require the prior approval of the Charity Commissioners for England and Wales.
- 15. The Society may be dissolved by a resolution passed by a two-thirds majority of those present and voting at a General Meeting. In the event of dissolution, any property remaining after the satisfaction of all debts and liabilities shall be given or transferred to such other charitable institution or institutions having objects similar to the objects of this Society as the Charity Commissioners or other authority having charitable jurisdiction may determine.

Trustees The Council members constitute trustees of the charity for the purposes of charity legislation, having due regard to the qualifications, reputation and relevant abilities of the candidates. Explanation of the legal duties and responsibilities of trustees is given by the Secretary to new trustees, and all trustees are advised of any changes to relevant legislation and recommended best practice.

Risks are identified, determined, evaluated and managed by regular review of operating conditions, and by the maintenance of a risk register, which is reviewed at least annually by the Finance and Publications Committee. The major risks to which the Society is exposed relate to market conditions surrounding its investment portfolio, data loss relating to its financial and administrative records, and the loss of the officers without adequate provision being made for their replacement and the transfer of knowledge. In the trustees' opinion, reasonable steps have been taken to reduce exposure to these risks.

Data Protection: In May 2018 the General Data Protection Regulation (GDPR) came into force. This regulates the processing of personal data by organisations. In order to ensure the Society's

compliance the officers have drawn up a Data Protection and Information Security Policy. This sets out the personal data the Society collects and the mechanisms by which it seeks to process further, manage (including destruction) and store that data, in order to comply with this legislation and fulfil the contractual agreement between Society and member with regard to the benefits of the subscription. It also outlines procedures for review and revision in line with future legislation. Full details of the policy are available on our website.

Objectives and Activities

The Society's objects are noted above.

Activities are established by the trustees to meet and accord with the Society's charitable objectives. In addition to the publication of historical documents relating to the diocese and ancient county of Lincolnshire, the Society also makes grants for research and other purposes which, in the opinion of the trustees, will further the Society's objectives. The Society also organises events for its members and the general public which help to achieve its objectives. It also actively communicates with its members via social media and email as well as print publications.

Public Benefit: The Trustees having regard to the guidance issued by the Charity Commission in deciding what activities the Society should undertake, the Society makes its volumes freely available to the general public by appointment with Lincoln Cathedral Library where two sets of its publications are held. The Society's volumes are also stocked by many public libraries and archives, and are available for sale to non-members on payment of the cover price in force for the time being. The Society's website, Facebook and Twitter pages are available to all Internet users, and contain information about its work, publications, grant-making programme, linked organisations, and events open to the general public.

Volunteers: The Society's trustees are all volunteers, and it has not yet needed any other volunteers who are not trustees. It is estimated that the trustees contribute some 1000 - 1500 hours per annum of their time to the running of the Society. The equivalent financial benefit of these hours of professional time may be in the region of £100,000 per annum.

Achievements and Performance

Membership: This year the society welcomed 13 new members and notes the resignation of 10 members. We are sorry to report the deaths of Nigel Burn, Pat Firman, Dennis Mills and Brenda Webster. At the end of the year the society had 317 members compared with 315 at the end of last year.

Publications: During the current year the Society published Volume 108 in the Original Series, *Petitions from Lincolnshire c.1200-c.1500*, edited by Gwilym Dodd and Alison McHardy. This is

an edition of almost 200 petitions to the Crown, originating from the county, and now held in the National Archives. The petitioners include both men and women, aristocrats and peasants, merchants and townsfolk, bishops, abbots and other clergy. The volume was issued to individual members in March 2020 (despite the lockdown); it will be issued to institutional members once restrictions have been lifted.

Three other volumes are at an advanced stage. The first of these is *Stukeley and Stamford, Part I: Cakes and Curiosity, The Sociable Antiquary 1710-1737*, edited by Diana and Michael Honeybone. This will include three texts from the early part of the career of William Stukeley, largely relating to the years he spent in the town of Stamford: the Iter Oxoniense (1710), Stanfordia Illustrata (1735-6) and the minute book of the Brazen Nose Society (1736-7). The second is *The Hall Book of Grantham 1662-1704*, edited by John Manterfield and his team of transcribers. This will complete the work of publishing the earliest of Grantham's borough records, begun by the late Bill Couth in 1995 (LRS, Volume 83). The third is *Stukeley and Stamford, Part II: The Designs of Stanford Antiquitys 1735*, edited by John Smith. This will partner the Honeybones' edition, noted above. The *Designs* are a series of illustrations planned by Stukeley as a complementary work to *Stanfordia Illustrata*. -In order to do justice to these remarkable drawings, this edition, which will also include an edition of *The Historical Part of Stamford Election 1734*, Stukeley's account of alleged malpractices during that contest, will be published in a larger format.

Also making steady progress is the third part of Nicholas Bennett's *Lincolnshire Parish Clergy* series, covering the large deanery of Calcewaith, thirty-nine parishes including Alford and Mablethorpe. A number of other volumes are in active preparation. The Society is most grateful to all those who are preparing future volumes for its series. The publication schedule of the Society is dependent upon the commitments of editors and it is not possible therefore to give definite dates for the publication of volumes in active preparation.

Other Activities: The global coronavirus pandemic has placed severe restrictions upon the activities of the Society and will do for considerable time to come. The Society is exploring new ways of delivering activities for members. Nonetheless, there has still been a number of important activities on which to report.

The Society continues to work on providing digital access for members to its publications; the website has now been placed on a secure platform by Ipswich Computer Services and the Finance and Publications Committee continue to explore solutions to creating the optimal platform for delivery of searchable text. Volume 1 of the Data Series, *Fossdyke Toll Accounts*, edited by Dr Rob Wheeler, continues. A second volume ('A Threshing Contractor's Day Book, 1909-16, ed. Ken Redmore) has been accepted for publication and Dr Wheeler is looking for other potential volumes.

Two further editions of the Society's News Review, edited by Dr Marianne Wilson, have been published in the year under review. Issue 14 featured a preview of the latest volume *Petitions from Lincolnshire*, *c. 1200-c. 1500*, ed. G. Dodd & A. K. McHardy, trustee Professor Edmund King introduced his favourite volume, the *Registrum Antiquissimum* and the work of Canon C. W. Foster and Professor Kathleen Major in its production, while Dr Brian Hodgkinson gave a detailed review of the subject of his doctoral thesis, the accounts of the churchwardens of Louth in the sixteenth century. Dr Gwilym Dodd supplied the introduction. Issue 15 begins with an introduction by trustee Chris Johnson, which focuses on his career and relationship with the archives of, particularly, premodern Lincoln. The edition also includes a précis of papers from the Wars of the Roses conference

(see below) and an obituary for member Nigel Burn. Dr Claire Hubbard-Hall and Dr Hazel Kent provided an article on Civil Defence in Lincoln, 1939-45, an introduction to their forthcoming volume, while Dr Rob Wheeler contributed an introduction to the Data Series I volume on the *Fossdyke Toll Accounts*. Dr Wilson herself published a short piece based on her article she published in October 2019, 'Peacock Feathers and Pater Nosters: the post-mortem identity of Sir Thomas Burgh (c. 1430-1496)'. Dr Martin Roberts, who has just completed a doctoral thesis at the University of Nottingham, discusses his research on the bishop of Lincoln's court of audience in the early sixteenth century.

The Society's social media profile has gone from strength to strength over the year: our Twitter feed (@LincolnRecSoc) now has 493 followers (an increase of 68 over the year) and allows interactions from interested users worldwide. Our new mailshot service to members, Mailchimp, now has over 200 subscribers and allows the Society to share promptly news of upcoming events organized in and around Lincolnshire.

The Lincoln Record Society Prize for the best MA dissertation in Medieval Studies at the University of Lincoln was awarded to Charlotte Blueitt for her thesis 'A Bishop. A King and a Martyr: the Context of Canonisation in Matthew Paris' Saints Lives'. The prize for the best MA dissertation in Historical Studies went to Cameron Huggett for his thesis "Creating the soundtrack to the second industrial revolution": Music, Youth and Cultural Reconstruction in Post-Industrial Sheffield, 1978-1990. The annual Dulcie Duke award at Bishop Grosseteste University has been made to Ryan Eccles. Winners receive £100 and three years' free membership of the Society.

Over three days in September 2019 the Society hosted its research conference "Lincolnshire in the Wars of the Roses". An evening lecture by Dr Anne Sutton kicked off proceedings in excellent style. Forty attendees enjoyed a fascinating introduction to the period entitled "A Seaside Journey in Yorkist Lincolnshire" at Bishop Grosseteste University. On the main lecture day over sixty delegates crammed into the International Bomber Command Centre and heard a range of excellent research papers from experts in the field: Dr Jonathan Mackman (York) and Dr Nicholas Bennett (LRS) provided detailed introductions and analyses of the Lincolnshire Rebellion and Battle of Losecoat Field in 1470; Dr Joanna Laynesmith (Reading) and Dr Rachel Delman (York) explored the careers and involvement in the local conflict of two prominent matriarchs, Cecily, duchess of York and Lady Margaret Beaufort; Dr Marianne Wilson (LRS) presented a richly-illustrated account of the post mortem provision of Sir Thomas Burgh, owner of Gainsborough Old Hall; while Dr Sean Cunningham (The National Archives) dug deeply into the archive to discuss the conspiracy among local officials to support the conspiracy of Henry Tudor against Richard III and Dr Claire Kennan (Reading) analysed the role of parish guild communities in Lincolnshire during the Wars of the Roses. The articles by Drs Bennett, Laynesmith and Wilson have recently been published in *The* Ricardian. The Society was pleased to host book stalls from the Society for Lincolnshire History and Archaeology and Shaun Tyas. Finally, a small group of delegates ventured out on the Sunday to some important local sites under the expert guidance of Society President Professor David Stocker. After visiting the fascinating church at Coates by Stow, with its surviving rood loft, and the Saxon Minster of Stow, the group spent the afternoon at Gainsborough Old Hall, exploring the building that was home to Sir Thomas Burgh. Plans for conferences in 2020 have been put on hold but the officers are exploring several options for research and early career conference in 2021 and 2022.

Grants: A grant of £1,000 was made to Dr. Sally Badham towards the cost of publishing her paper entitled *Semi-effigial and related monuments in Lincolnshire* in a festschrift for Jerome Bertram. A grant of £500 was made to Dr. Mike Jefferson towards the cost of publishing his book on *The Knights*

Templar of Medieval Lincolnshire. The annual grants budget is £10,000.

Legacies: Member Nigel Burn who joined the Society in 2014 died in March 2020. He generously left to the Society 50% of the residual value of his estate. This is likely be over £1,000,000. Probate was granted at the end of August. The income from this bequest will be reported in next year's annual report. In the meantime, the trustees have started to consider the implications of the bequest on the activities of the society.

Financial Review: Activities and hence income have been severely restricted due to the Covid19 pandemic. Investment income from our portfolio managed by Brewin Dolphin was £13,963 (2019 £14,222). The cost of managing our portfolio was £3,027. As at July 31st the value of the portfolio was £331,781 a reduction of £27,059 compared with last year's figure.

Subscription income was £5,492 compared with £7,066 last year. This reflects the late payment of subscriptions.

Book sales were £1,433 (2019 £2,820).

ON DELLATE OF THE DOADD

Total expenditure was £21,331 (2019 £11,468). This year we published Volume 108 which cost £7080 plus £1,069 for partial distribution. Institutional distribution will take place in the next financial year.

Expenditure exceeded income this year by £282. The reduction in the value of investments was £27,059 which compares with a growth of £58,091 over the previous five years. The net expenditure over income was £26,777.

As agreed by Council the Kathleen Major fund has been adjusted in line with inflation. It now stands at £300,908.

Surplus funds are invested in the Charities Official Investment Fund which is managed by the CCLA. The Finance and Publications Committee undertake regular monitoring and review of investments. Investments held by Brewin Dolphin are in a nominee account.

Reserves Policy: The balance held on the Major Reserve will be held in line with a suitable price index. The remaining funds are available for application and the Trustees have instigated a grant making programme. The Trustees will retain general reserves adequate to fund the average cost of one publication and a certain level of grants to assure the future of the society. The five year plan has been designed with this in mind. This policy will be reviewed as part of the review of our activities following receipt of the Nigel Burn bequest.

1 ACCOUNTING POLICIES

The following accounting policies have been used consistently in dealing with items which are considered material to the charity's affairs.

a Basis of accounting

Lincoln Record Society is an unincorporated Charity. The address of the principal office is given in the Charity information page on page 1 of these financial statements.

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland. The financial statements have been prepared under the historical cost convention, with the exception of investments which are included at market value.

b Legacies

Legacies are recognised when the sum to which the charity is entitled is known, the receipt is probable and entitlement has passed to the charity.

c Subscriptions

Subscriptions are recognised in the period to which they relate.

d Investment income

Interest on deposits is accounted for in the period when it was earned.

e Expenditure

Expenditure is included in the year to which it relates rather than the year in which it is paid. Expenditure includes irrecoverable VAT. Support costs are those costs incurred in running the charity's activities and the strategic overall management of the charity. Expenditure has been presented in line with the alternative method.

f Fixed assets and depreciation

Fixed assets are included at cost less depreciation. There is no formal capitalisation limit. Depreciation is calculated so as to write off the cost of an asset, less its estimated residual value, over the useful economic life of that asset as follows:

Website over 3 years Facebook Project over 3 years Digitisation Project over 5 years

g Investments

Investments are stated at fair value at the balance sheet date. The Statement of Financial Activities includes the net gains and losses on revaluations and disposals throughout the year.

h Stock of books

Book publication costs are written off as incurred. Stock is not valued in the accounts.

i Funds

Designated funds have been identified by the trustees and set aside for a specific purpose as described in the trustees report. General funds are those funds which are available to the trustees to apply for the general purpose of the charity.
